2. Introduction

One World One Family Foundation Malawi is a Youth led and independent, non-governmental, and non-profitable social organization established by a group of like-minded youths with experiences in different sectors to promote youth capacity development and provide opportunities to youths. It was registered with the Registrar General Office, Blantyre on February 5, 2024 under Government of Malawi Company cap 46:03.

One World One Family Foundation Malawi is actively engaged in a diverse array of initiatives encompassing youth professionalism, development, and capacity-building, healthcare, education, research, environmental sustainability, climate change mitigation, as well as empowerment programs targeting youth and women. Our overarching objective is to foster the professional development of vulnerable and marginalized youth, equipping them with the requisite skills, opportunities, and initiative through result-oriented research and programs.

One World One Family Foundation Malawi aspires to improve the living conditions of the poor and marginalized groups by adopting strategies through community initiative, participation, and sensitization. It was founded in 2014 as a community-based organization and evolved to a main NGO in December 2023. The foundation's main working field is Thondwe and Mwanda, Zomba, T/A Mlumbe. If necessary, the foundation conducts programs out of T/A Mlumbe. Hence, it has been also working among backward communities in the interior unreached pockets in Zomba. Youth self-support groups have been taken as the base for all interventions and Malawi 2063 activities enabling them to contribute towards the mainstream of the development process. It has had partnerships with national and international organizations. Likewise, the foundation has already worked with local organizations in youth entrepreneurship, school health and hygiene, school teaching programs, reproductive health in schools, etc.

One World One Family Foundation Malawi comprises a diverse and dynamic group of competent young people from different backgrounds. The foundation has 7 executive members with 3 female members. Each member has specific qualities that have helped to sustain and run the organization. From health to management, pharmacy to administration, social sciences, and information technology, the team comprises diverse groups and the key members of the team are well-equipped with skills in writing grant proposals and applications, planning, implementation and monitoring of programs, report writing, research and M&E, coordination & management, and innovations and application of technology.

2.1 Mission

To make today's young future leaders, promote young generation & professional quality, ensure sustainable and build up inclusive social development for improved quality of life for all.

2.2 Aim

Our main aim is to provide youth professional skills, development, and learning opportunities for the poor and excluded society generation focus to strengthen them. We plan to achieve our aim by developing, testing, and delivering evidence-based, feasible, and cost-effective interventions relating to professional and social development with greater involvement of youth programs and communities. We support the government initiative aimed at poverty reduction in line with the sustainable development goals and targets.

3. Organization's Objectives

The main objective is to contribute to young generation professional development, implementation, and scale up of evidence-based and cost-effective interventions in young professional and social sectors. The specific objectives are:

- To gain a greater understanding of community development issues and explore possible solutions through quality research and development keeping the focus on youths.
- To promote quality communications towards the development of evidence-based policy and practice in the field of youth.
- To review and analyze the policies and programs' effectiveness at local and national levels and understand their implications in professional services and social development.
- To ensure functional linkage and collaboration among policy makers, program managers, researchers, social scientists, and institutions with similar objectives with a view to the institutionalization of program-based operational research in youth programs.
- To enhance access to information on young generation and social development sector to policy makers and practitioners.

- To involve youths in the field of health, education, environment, and economic activities and programs.
- To support government initiatives in the field of youth involvement, youth development, and youth-related policies.

4. Scope of Work and Target

One World One Family Foundation Malawi is an independent, non-profitable non-governmental organization (NGO). It is mainly concerned with implementing non-profitable social work in the field of youth, healthcare, Nutrition and Education. We focus on providing opportunities and involvement of young generation and development of professionalism for creativity, community enhancement, and development and prosperity.

Basically, the foundation will function in youth leadership, democracy and development advocacy of social issues, youth professionalism & involvement in agriculture, natural resource conservation & climate change, women empowerment, social and economic advancement, primary health & education. We promote and secure vulnerable group and exclude society generation life by professionalism. We also provide opportunities to those people who are looking for professionalism. We make them initiative & capable with result-oriented research & programs.

5. Working Modalities

One World One Family Foundation Malawi works with youth development programs by implementing organization collaboration with the Malawi government. The foundation works in collaboration with the government, I/NGOs, and community groups as relevant. Moreover, we collaborate with local governance, private professional development, care providers, and teaching institutions, young professional organizations, and corporate sectors for the effective implementation of the foundation's programs.

Our current practices of implementing programs and activities include getting approval from the concerned government agencies (Zomba Social Welfare, Ministry of Education Zomba office, Chiefs, and Council for Nongovernmental Organizations in Malawi (CONGOMA), NGO regulatory Authority

(NGORA)). After the approval, an induction meeting is conducted with all relevant stakeholders and partners to inform and communicate about the programs. Likewise, communication and coordination are done with local level stakeholders and local partners.

Only after approval and coordination with all stakeholders, the program/activities are implemented in the concerned areas. After the program implementation, program evaluation and feedback are collected. Necessary reporting is conducted to the concerned agencies and the program comes to the end in the closure phase.

Currently, the foundation is working in coordination and partnership with the following government and non-government stakeholders and will continue to engage the stakeholders as follows:

- **Coordination with National Youth Council (NYC), Malawi**

NYC believes that youth are the most active, energetic, and dynamic group, which is considered the agent of political, economic, and social changes in any country. Its vision is to make Malawi's youth strong, competent, competitive, and self-reliant, to build a modern, just, and affluent Malawi through their meaningful participation and promotion of their leadership capacity. Hence, the foundation will coordinate with NYC for all aspects of the programs' implementation with NYC and monitoring. The representatives of NYC will be invited to all the relevant activities for their meaningful participation. Also, regular meetings will be held with NYC.

- **Youth-serving organizations**

Malawi has a relatively large network of youth-serving organizations; however, the vast majority are only province or local in scope. Larger local and international NGOs are active in Malawi that are working in the field of sexual and reproductive health. Hence, the foundation will initiate mapping of youth-related organizations and involve them in the program as and when necessary. Among all, the local youth-related organizations will be focused. Their organizational capacity will be developed.

- **Local government bodies and health authorities**

The foundation has been coordinating with local government bodies such as municipalities and wards. The concerned responsible authorities are informed about the program and the activities conducted

accordingly. Likewise, different health institutions are also involved in health-related programs. The health post and primary health care centers are also involved in all relevant programs.

- **Coordination with Ministry of Youth and Sports**

At the policy level, the foundation is coordinating with the Ministry of Youth and Sports. All the youthrelated policies, strategies, directives, and plans are governed through the ministry. Hence, the ministry of youth and sports is the key stakeholder in the foundation's youth projects. The foundation involves the ministry from the inception of the program and communicates with the ministry on all relevant issues and the progress of the projects. Regular meetings are conducted with the officials of the ministry and participants/focal persons from the ministry are invited to different programs and activities. The ministry also plays a role in monitoring and supervision of the project activities.

- **Coordination with the Ministry of Education in School Feeding Program**

Since the inception of the 2023-2024 academic year, One World One Family Foundation Malawi has forged a collaborative partnership with the Ministry of Education aimed at enhancing the well-being and educational outcomes of students in Zomba. Through a Memorandum of Understanding (MoU), the foundation and the Ministry of Education have jointly initiated a School Feeding Program across five primary schools within the region. These schools include Gala Primary School, Dindi Primary School, Mwandama Primary School, Nankumba Primary School, and a Community Child-Based Care Centre. The program's objective is to address the nutritional needs of students, thereby promoting better concentration, attendance, and overall academic performance. This coordinated effort underscores the foundation's commitment to supporting education and ensuring the holistic development of youth within the community.

The foundation will continue to coordinate and partner with all relevant government (central, provincial, and local) as well as non-governmental organizations for the implementation of the programs.

6. Geographical Coverage

The foundation is registered in Zomba, T/A Mlumbe,Dowa and Nkhatabay districts but has the approval to conduct the programs and activities in all districts of Malawi. Thus, the foundation is able to conduct activities along with its network and partners in all districts in Malawi. We will be implementing different activities to support Malawi.

- Zomba District: T/A Mlumbe, GVH Mpanje and Yotamu, T/A Malemia, Gvh Wadi
- Dowa District: T/A Chakhadza
- Nkhatabay District: T/A Fukamapiri

Also, the foundation has a network of individuals and youth-related organizations in different provinces and districts of the country. To implement any programs in the districts, the foundation has the capacity to engage and mobilize individuals as well as the organizational networks to implement the programs. Many programs have been conducted in a similar manner in the past and hence we would continue the similar modality in implementing activities across different districts.

7. Major Working Areas

The major working areas of One World One Family Foundation Malawi are diverse. The areas of work will bring about different programs and projects for youth professionalism. Also, it will help them in uplifting their life standards. Similarly, it will help them identify their interested fields and motivate them to engage in different sectors. Therefore, youth can contribute to the holistic development of the nation. The Malawi government Youth policy also inspires youths towards entrepreneurship and advancement of science & technology. Consequently, they become initiative & enthusiastic to create a perfect society & the nation as expected. In this respect, we believe this organization can play a crucial role in nation building as well and finally succeeds in achieving its goals.

Thus, the major working areas of the foundation are:

- Nutrition
- Education
- Healthcare

8. Major Activities Completed and Achievements

The foundation had been mainly conducting activities in the field of youth development and empowerment as well as social development. The major activities that the foundation has completed are: Youth for Pollution-free Zomba Program, a local youth exchange program that aimed to develop skills among youths for leadership and community service, and Plastic pollution advocacy.

Apart from this, the foundation has been actively engaging in regular programs such as health camps, blood donation, and awareness programs. It collaborates with the relevant stakeholders, i.e., FHI 360 in Zomba district and Zomba DHO in conducting such programs/activities.

Similarly, there is another area where it gets involved in school health programs, i.e., School Feeding Program at Mwandama Primary School, and it provided entrepreneurial skills and knowledge as well as awareness to school children on various health-related topics like sanitation, personal hygiene, Covid-19, Cholera, HIV, Drug Addiction, reproductive health, sex education, etc. In the beginning of 2023, the foundation was involved in providing Covid-19 and anti-corruption training to Thondwe communities in Zomba.

One World One Family Foundation Malawi has also been involved in different health programs and TB is one of the major working areas. The foundation has been working with Zomba DHO in Covid-19 management among Thondwe community in Malawi, in the areas of capacity development of health workers, screening of Covid-19 among children and old people, referral and linkages for treatment, care, and support as required. The foundation in coordination with FHI 360 is conducting regular Covid-19 screening awareness among communities in their settlements as well as in schools, where screening, diagnosis, referral, and treatment is being conducted. The foundation supports in identifying and management of Covid-19 cases among Thondwe communities in Zomba.

One of the foundation's major working areas is reproductive health and we aim to implement programs related to youth reproductive health in Zomba. In the context of the importance of reproductive health among youths, we plan to work in the different components of reproductive health: Family Planning, Adolescent Sexual and Reproductive Health, Infertility, Reproductive Tract Infection/Sexually Transmitted Infections and HIV/AIDS, Neonatal Care, Maternal Care, Elderly Care, and Gender-Based

Violence. In addition, the foundation is also interested in activities related to Reproductive and Sexual Rights, and Ethical Issues and Reproductive Health Policies, Strategies, and Evaluation.

The details of the major activities completed by the foundation are described below:

YSEEAN

Youth Social Entrepreneurship Education for All with NEDTECH

YSEEAN takes roots on the threshold of the Industrial revolution in which innovation and skills and massive digitalization are predicted to radically alter the status-quo relation between trainers-trainees, youth workers-youths, and their place in the learning process; as well as the future's changeable skills demand. Entrepreneurship, Analytical thinking, Leadership, and Social Influence are predicted by the World Economic Forum (2018) to continue to be the most essential skills for future jobs. In the face of those challenges, youth work shall need to anticipate trends and adapt to new technological changes in order to confirm its indispensable role in the new digital age.

Objective

The project aims to consolidate the role of youth workers in promoting youth social entrepreneurship by enriching them with the core knowledge of social entrepreneurship, youth work skills, and particularly the technical know-how to open their relevant courses with NEDTECH as a new, innovative, far-reaching way of doing youth work. Simultaneously, YSEEAN aspires to develop a new form of youth work methods in the efforts to make its digital shift.

Main Activities and Results:

Towards the above goal, YSEEAN plans a series of interlinking CB and Mobilities activities within 24 months that shall result in the production of locally produced products that can compete on international and local markets.

Adolescence Sexual and Reproductive Health Programs

The foundation has been involved in orientation and training programs related to adolescence sexual and reproductive health programs in different schools and colleges. The main objectives of the program are to increase awareness and understanding about sexual and reproductive health among school students.

Different orientation programs have been conducted in coordination with the schools.
